

ELIGIBILITY

The Snowmass Culinary & Arts Festival is a nationally juried art and culinary exhibit. ALL artists must be juried and accepted. Artists will be selected based on the originality and quality of their work. All work that is submitted must be original in concept, design and execution. Kits or mass produced goods are not acceptable (including commercial production, photography, commercial jewelry and clay molds). We encourage all artists in various media categories including: ceramics, drawing, fiber, glass, graphics and printmaking, jewelry, metal-works, mixed media, painting, photography, sculpture, and wood. EXHIBIT SPACE

The Snowmass Culinary & Arts Festival aims to host approximately 50 plus artists and culinary aficionados. All booth locations will be in an outdoor setting on the Snowmass Village Mall. Organizers reserve the right to determine booth locations. If you have participated in a Snowmass event in the past and have a booth location preference, please specify.

Standard booths are 10'x10', however 10'x20' booth spaces will be offered as well.

There will be two booth options for artists. The first, being a "build your own booth" and the second being a professional booth provided and built by the Event Organizers. This booth includes a white three sided tent, banquet table and cloth, and 1 chair. All booths provided by Event Organizers will be located together in a professional artist display.

Artist booths will be open on Thursday evening for the Summer of FREE Music concert series bringing thousands to Snowmass Village.

LODGING

Special lodging rates will be available to participating artists at the host hotel. Information will be provided in a Confirmation Package upon acceptance to the show.

FESTIVAL GUIDELINES

All artists should return the enclosed application completed and signed. Deadline for submitting applications for the festival is May 30, 2011.

Include the following photos:

- 4 photos displaying your work and/or website displaying your work
- 1 photo displaying your booth, if you are building your own booth display
- Mark all photos with your name

All artists must enclose a brief resume listing your training, other shows you have participated in, and any shops or galleries which have carried your work. All artists must have a visually pleasing and artistically creative booth set-up.

Please include an appropriate sized self-addressed stamped envelope for a prompt return of your photographs. Booth fees and photos will be returned to you if you are not accepted into the show.

Note on the outside of your application "Snowmass Culinary & Arts Festival" and the category in which you wish to be juried.

FESTIVAL FEES

Two checks must be included in your application made payable to Town of Snowmass Village:

1. Booth fee of:
 - \$250 10'x10' Build Your Own Booth
 - \$325 10'x20' Build Your Own Booth
 - \$750 10'x10' Professional Booth
 - \$1,000 10'x20' Professional Booth
2. Non-refundable jury fee of \$25

Checks will be deposited upon receipt of application. Checks will only be refunded if you are not accepted.

A \$25 fee will be charged for all returned checks. No refunds will be issued to an accepted artist who cancels after June 15, 2011.

TAXES

Accepted applicants MUST complete a vendor license application and pay a vendor fee of \$15. The application will be given to you upon artist check-in on Friday, July 22. The total tax that will need to be collected on sales is 10.4% (3.5% Town, 2.9% State, and 3.9% County). You will receive a sales tax remittance form with your vendor license. This form will be used to remit 3.5% of the sales tax collected to the Town. You will need to contact the State of Colorado to see if you must obtain a state license, and you will need to remit the 2.9% for the State and 3.9% for the County directly to the State.
